

**TOWN AND COUNTRY PLANNING (GENERAL PERMITTED DEVELOPMENT) ORDER
2015 (AS AMENDED)**

IMMEDIATE DIRECTION MADE UNDER ARTICLE 4(1)

SEETHING WELLS FILTER BEDS SURBITON

WHEREAS the Royal Borough of Kingston upon Thames being appointed the local planning authority within the meaning of Article 4(4) of the Town and Country Planning (General Permitted Development) Order 2015 (as amended) is satisfied that it is expedient that development of the description set out in the Schedule below should not be carried out on the land known as Seething Wells Filter Beds and shown outlined in red on the attached plan ("the said land"), unless permission is granted on an application made under Part III of the Town and Country Planning Act 1990 (as amended).

AND WHEREAS the Council is of the view that development of the said description would constitute a threat to the amenities of their area

AND WHEREAS the Council at a meeting of its Culture Housing Environment and Planning Committee on 17th March 2021 authorized the confirmation of the said Order under paragraph 1(7) and in accordance with paragraphs 1(9) and (10) of Schedule 3 to the said Order with the modification shown in italic print in the Schedule

NOW THEREFORE the Council in pursuant of the power conferred on them by Article 4(1) of the Town and Country Planning (General Permitted Development) Order 2015 (as amended) hereby direct the permission granted by Article 3 of the said Order shall not apply to development on the said land of the descriptions set out in the Schedule below.

SCHEDULE

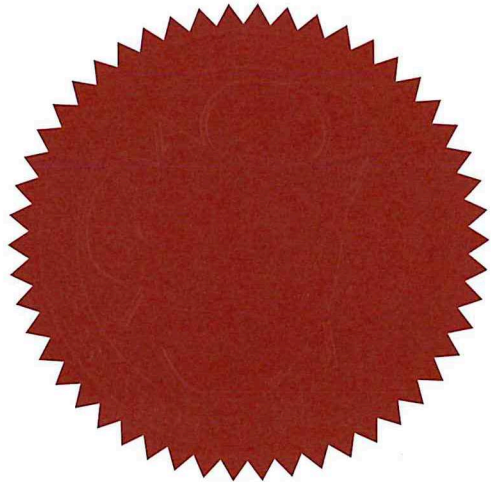
The erection, construction, improvement or alteration of a gate, fence, wall or other means of enclosure comprised within Class A of Part 2 of Schedule 2 to the said Order and not being development/use comprised within any other class *SAVE THAT this provision does not restrict the repair maintenance or replacement of any existing gate fence wall or other means of enclosure on the said land PROVIDED THAT such works replicate any existing means of enclosure in design form height and materials used*


